

DCM Report: August 15, 2026

Pre-Assembly

Pre-assembly was held on August 1. All of the information I'm sharing with you today is available on the area's website area72aa.org. I grabbed a few copies of the motions and discussion topic background packet from the preassembly and pass them out to some groups. I also printed out a few extra that I have here for anybody that didn't get one. You can also find this packet at the Area 72 website under October assembly documents. Here are the bullet points:

- **Motion #1: Sound Chair Appointment Process**
Move to supplement Motion 22.3 that the Tech Steering Committee will select the Sound Chair for the next rotation subject to approval by the electeds during their appointed selection process and ratified by the Area Committee at the first Area Quarterly Meeting of each rotation.
 - **Motion #2: Amend Motion 23.2 to No Geographic Boundaries within Conference Area**
Move to amend Motion 23.2 to read: In the spirit of unity, we affirm that District 25 is an online district with no geographic boundaries within the General Service Conference area of the United States and Canada.
 - **Motion #3: Special Online Assembly for Proposed Agenda Items Only**
Move that, if the Area Committee approves a motion that qualifies as a Proposed Agenda Item for the Conference to be voted on at the Assembly, that the Area hold a one-day Special Assembly online in September on just the Proposed Agenda Item Motion(s) in time to submit to the General Service Board by the deadline date. The Motion and all background information are to be included in all pre-assembly materials and in the August edition of the Newsletter, with the Annual Assembly to continue to be held in October.
- Motion #4: Move Assembly to last weekend before September 30 PAI Deadline Date**
Move that, going forward, the Area Assembly be moved to the last full weekend in September that is before September 30, as soon as feasible, so that future Assemblies are before the Proposed Agenda Item Deadline Date.
- **Discussion Topic #1: Area Third Legacy Standing Committee** (Could go to a floor motion, but not likely)

Area 72 Inventory Report: all of the DCM's that were present during the January quarterly participated in the area 72 inventory. A committee was formed to filter through and find key points for the area to work on. The final report will be presented at the October assembly.
